# **Holding steady**

### Real estate industry maintains growth amid inflation, rising interest rates

Rising interest rates have posed a challenge for commercial real estate in the past year. As the transaction market cooled, valuations have shown some signs of softening. Falling stock prices further affected the industry, creating a denominator problem for investors..

Amidst these challenges, the global real estate industry grew by 7 percent year-over-year, according to the findings of Global Investment Managers 2023, the results of the annual survey sponsored by Property Funds Research and Institutional Real Estate, Inc. The survey received responses from 228 investment managers that represent total global real estate assets under management of €5.57 trillion (based on 2022 AUM figures), an increase from the previous year's survey total of €5.1 trillion (based on 228 survey respondents).


Real estate's role as an inflation hedge has been tested in the post-pandemic era, though investors have been attracted by its stability and performance. In 2022, investment managers raised €124.9 billion for private equity closed-end funds that closed during the year, according to the IRELQ database, down from €154.8 billion in 2021.

"2022 presented a great deal more challenges for investment managers than did 2021," notes Geoffrey Dohrmann, chairman and CEO of Institutional Real Estate, Inc. "Weak equities markets, higher inflation and rising interest rates helped contribute to the return of a denominator problem for many pension funds and other institutional investors. As these investors struggled to rebalance their portfolios, large exit queues began to form in the majority of open-end funds, along with a corresponding rise in secondary market transactions for closed-end funds and some asset liquidations in separately managed accounts. Write-downs in the office, retail and a handful of noncore property type sectors counterbalanced some of this effect but also put pressure on asset value—based investment manager revenues. At year-end, additional write-downs were anticipated as the Fed and other central banks around the world continued to raise short term

rates in an effort to battle inflationary pressures. With no hint of when these conditions would improve, 2023 was expected to pose an equally challenging environment for investment managers."

There were no surprises in the top-ranked firms, with the same organizations in the same order rounding out the top five. The industry's largest investment manager is once again Blackstone, which reported total real estate AUM of €473.5 billion, more than twice as much as the No. 2 ranked Brookfield Asset Management, which oversees AUM of €229.9 billion. Also holding steady in their same places were MetLife Investment Management (€177.9 billion), PGIM Real Estate (€148.3 billion) and Nuveen Real Estate (€144.7 billion). rankings control  $\in$ 1.77 trillion of AUM, an increase of 4 percent from the previous year's figure of  $\in$ 1.6 trillion. The Top 100 firms in this year's rankings represent  $\in$ 5.15 trillion, an 18 percent jump from the previous year's total of  $\in$ 4.54 trillion.

"Although we may not be seeing major changes amongst the larger managers, we are witnessing movement within the mid-sized managers, some of which can be associated with increased M&A activity, rebranding and sale of non-real estate specific parts of businesses," says Jane Fear, managing director at Property Funds Research. "It is these mid-sized managers who are more likely to be finding the downward pressures on fees and rising costs to be a drain on their businesses. In 2022, over 13 significant corporate events were disclosed as part of the survey. This compares to only 11 events in 2021 and five in 2020. Most of these deals impacted managers with AUMs between €30 billion and €5 billion. In the next years, we expect the real estate fund management industry to stabilize with lower growth rates, with managers focusing on cost efficiency and

the ESG transition. We expect more activity for funds investing in residential, debt and alternatives, such as age or technology-related sectors, while the office sector is expected to decline further. The Global Investment Managers survey provides a valuable insight into the industry and the changing investment sentiment, and we very much appreciate everyone's help in completing the surveys."

Blackstone ranks as the largest investment manager based on AUM in North America alone. The firm manages  $\[ \in \]$  212.4 billion in the region. In Europe, the top-ranking manager is Swiss Life Asset Managers, with AUM of  $\[ \in \]$  112.2 billion, and in Asia, ESR Group claims the most assets with AUM of  $\[ \in \]$  101.9 billion. In the Australasia region, Charter Hall ranks No. 1 with AUM of  $\[ \in \]$  46.3 billion. Keppel Capital Holdings oversees the most assets in Latin America, with AUM of  $\[ \in \]$  7.2 billion. The report also ranks real estate managers based on their total AUM in the categories of discretionary separate accounts under management, advisory separate accounts and assets, and indirect real estate investment vehicles. NYL Investors manages the most capital based solely on discretionary separate accounts, with AUM of  $\[ \epsilon \]$ 59.0 billion (see page 13). In the category of advisory separate accounts, MetLife Investment Management tops the list, with AUM of approximately  $\[ \epsilon \]$ 165.4 billion (see page 17). And based on indirect real estate investment vehicles, Blackstone ranks highest, with an asset base of  $\[ \epsilon \]$ 416.0 billion (see page 21).  $\[ \epsilon \]$
